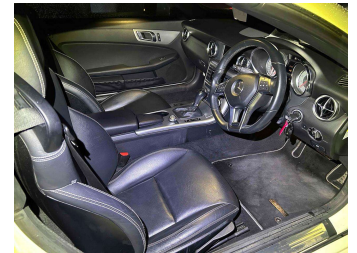

These fees can vary per lender and other non-mandatory fees and charges may also apply. The total amount of repayments has been calculated by multiplying 156 weekly repayments (based on a 36 month term) by the weekly repayment amount of \$224.88 which equals \$35,081.66.
