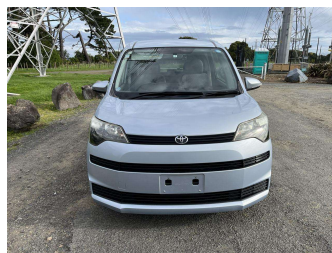

These fees can vary per lender and other non-mandatory fees and charges may also apply. The total amount of repayments has been calculated by multiplying 208 weekly repayments (based on a 48 month term) by the weekly repayment amount of \$48.12 which equals \$10,009.45.
